In a criminal court the paper moves first and fast — a bail application the same evening, a complaint that must survive scrutiny, a discharge application filed before the charge is framed. This course is built around the documents a junior actually files, now under the Bharatiya Nagarik Suraksha Sanhita, 2023 — bail and anticipatory bail applications, private complaints and Section 156(3) applications, protest and quashing petitions, discharge applications, cross-examination, written arguments, appeals and revisions — along with the courtcraft that decides how each is received.

How the sessions run

LIVE, NOT RECORDED LECTURES

Every session is taught live on Zoom, 90 minutes, with questions taken through the class.

DRAFTING AND COURTCRAFT TOGETHER

Sessions are built around live drafting on a real fact pattern, with model drafts and formats shared after class.

RECORDINGS FOR REVISION

Each session is recorded and stays in your account for the full course period, so a missed class is never a lost class.

TAUGHT ON THE BNSS

Every provision is taught in its new form, with the corresponding Code of Criminal Procedure, 1973 position flagged alongside.

Taught in Telugu

Teaching, discussion and doubt-clearing are in Telugu. Drafts, formats and statutes stay in English, as they are filed.
